### Herstory of European Feminist Forum

The monograph on European Feminist Forum was written by six European Feminists coming from different backgrounds, cultures, countries or continents who were excited to 'construct' a feminist vision for a social, economic and political justice in Europe. The publication "points to some of the core feminist debates in Europe around solidarity, affinity, movement organizing, body politics and sexualities, economic precarity, funding and migration. The main conclusion from the EFF experience is that there is no one European feminism but a plurivocality of European women's voices that are taking up feminism in different themes and activities. Nor is there a clear one Europe. (...) Similarly, the EFF emphasizes that there is no such phenomena as 'European feminism'. Nor is there agreement about what 'wave' of feminism we are in, or indeed if it is good idea to talk about waves."

The EFF initiative as a project is over, but a debate on rebuilding and re-politicizing the European feminist movement has continued.

KARAT was actively involved in this European feminist initiative since the beginning and contributed to writing its herstory, which was just published (by the end of 2009).

## **KARAT's program for CEDAW**

In March KARAT completed the process of recruiting partner organizations for the three-years project being a part of its CEDAW program. The project aims at developing and implementing the strategies for effective use of CEDAW mechanisms in Azerbaijan, Kyrgyzstan, Tajikistan and Uzbekistan. Its agenda includes activities on regional and national level which embrace CEDAW and OP CEDAW regional trainings of trainers, follow-up events organized in the project countries and actions taken to assess women's access to justice in the countries involved.

The partners organizations that will coordinate project activities on national level are: Gender Association "Symmetry" (Azerbaijan), Forum of Women's NGOs of Kyrgyzstan, Public Foundation "Panorama" (Tajikistan), "Generation of the Future" (Uzbekistan).

The rules for cooperation are to be developed during the strategic meeting that will take place on the 29<sup>th</sup> -30<sup>th</sup> of April in Warsaw. The meeting will provide forum for discussing the project strategy, its objectives and activities, including actions to be conducted on national level, and timetable of the steps to be taken.

## **Regional meeting on CEDAW Committee's Concluding Observations postponed due to volcanic ash**

We regret to inform you that the *Regional Consultation on the Implementation of the CEDAW Committee's Concluding Observations in Europe* which was about to take place on the 26<sup>th</sup>-28<sup>th</sup> of April in Warsaw has been postponed due to volcanic ash over Europe that caused extreme delays in flights and unabled participants and trainers to travel for the meeting. The meeting has been organized by International Women's Rights Action Watch IRAW Asia Pacific in cooperation with KARAT Coalition and WIDE Network. The meeting was about to bring together women's groups, academics and activists from the European region, with an emphasis on countries in which KARAT and WIDE have a focus.

The Consultation aims to assess the status of CEDAW application and to consider how to further use CEDAW and other human rights instruments in the work of participants' organizations. It will provide a space to examine the successes and barriers related to promoting and monitoring the implementation of the Concluding Observations of the CEDAW Committee in the selected countries in the region as a process for holding states accountable to their obligations under CEDAW. Further, the potential for strengthening the existing alliances as well as building the new ones, and developing national and regional strategies for promotion and protection of women's human rights, including effective state implementation of the Concluding Observations, will be explored during the meeting.

The new timing of the Regional Consultation will be settled as soon as possible.

## **KARAT in Clean Clothes Campaign**

On February 23<sup>rd</sup> and 24<sup>th</sup>, KARAT took part in the Eurometing of the Clean Clothes Campaign (CCC) as a representative of Clean Clothes Polska (CCP). It is the first Eastern European coalition in the CCC network. Together with three other Polish NGOs (Polish Humanitarian Organization, Polish Green Network and fair trade association eFTe) KARAT has established Clean Clothes Polska in order to continue the campaign for the improvement of the working conditions of women in garment industry.

KARAT is responsible for the international cooperation of CCP and for the first time it took part in activities planning and decision making of CCC. One of the topics discussed during the meeting was Gender Policy and strategy of CCC which is particularly important issue in the network acting for the improvement of working conditions in garment

industry where about 80% of workers are women. KARAT is involved in CCC Gender Working Group which has recently developed CCC Gender Policy Statement available at: <http://www.cleanclothes.org/about-us/what-we-believe-in/gender-policy-statement> and is currently working on CCC Gender Strategy aimed to be implemented within the network in Europe and by partners in producing countries.

## Polish Social Watch Coalition evaluates Social Development in Poland



On February, 26<sup>th</sup> Polish Social Watch Coalition (PSWC) launched its 2009 Report on Social Development in Poland at the panel debate that took place in the premises of Political Critique in Warsaw, Poland.

The discussion focused on the different perspectives regarding goals of social development: the one PSWC outlined and presented in its Report, as well as the vision elaborated in the governmental green paper “Poland 2030”. Among the speakers were Coalition members, academics and coauthor of “Poland 2030”.

This year Report is a product of Coalition’s debates on definition and understanding of social development. It consists of theoretical introduction as well as case studies illustrating interconnections between different dimension of development, including: access to housing, education and employment.

## Data gathering tours in Balkans completed

The participants of data gathering tours in Balkans have completed their tours in Macedonia and Serbia. With the support of local organization Permaculture and Peacebuilding Centre Shtip, they visited the towns Shtip, Zurnovtzi, Rusinovo in Macedonia and Bor and Belgrade in Serbia. The collected materials such as photos, interviews, records are the base for awareness raising tools, which will be created by the end of April, 2010. The following tools are being produced:

- a movie about the socio-economic situation of women in Balkan countries (by Elizabeth Dimitrova from Bulgaria),
- a blog with the photographs: real life reportage about Macedonian women (by Katarina Medlova from Slovakia),
- a blog with the photographs: stories of Balkan women living in different settings - poor suburbs, rural areas, city agglomerations (by Barbara Vodopivec from Slovenia). The blog is already available under the link: <http://tihezgodbe.wordpress.com/> .

The data gathering tours are the part of the project “Through Their Eyes, Through Ours. Raising Public Awareness about development problems faced by women from developing countries from Eastern Neighborhood, Balkans and Central Asia” co-financed by European Commission.

Political Club of Women 50/50 has launched the Gender Equality Prize. The aim of this Prize is to stimulate the interest of political parties and public persons from Republic of Moldova to promote gender equality and to facilitate their way to the Gender Equality Prize of the Council of Europe.

GE Prize will be awarded each year to recognize successes achieved by the political parties and public persons in supporting gender equality and promoting women in decision making.

Any non-governmental organization, institution or individual is entitled to nominate political parties or public persons to participate in the contest. Also, any political party may submit the application for the contest on its behalf.

The winner of the Gender Equality Prize will be chosen by an independent and impartial jury, composed of three persons, two experts in gender equality and a public personality.

### **Social Watch: The Gender Equity Index 2009**

The Gender Equity Index 2009 computed by Social Watch shows that the gender gap is not narrowing in most countries and a majority of the countries that show progress are those that were already comparatively better. The distance between the countries and regions in the better and worse relative situations has widened in the last years.

The GEI, produced annually by Social Watch from international available and comparable information, was designed to make visible gender inequity situations and monitor their development over time. It ranks countries and regions according to their performance in education, economic activity and empowerment - three dimensions closely linked to gender inequality.

The Association for Women's Rights in Development (AWID), the Center of Concern, Center for Economic and Social Rights (CESR), the Center for Women's Global Leadership at Rutgers, the State University of New Jersey (CWGL) and the International Network for Economic, Social and Cultural Rights (ESCR-Net) jointly release a new report.

This report aims to deepen our understanding of how governments have conducted themselves and how effective economic policies have been in defending and strengthening the enjoyment of human rights in a time of multiple and interlocking social and economic crises.
