Training of Trainers - Application of CEDAW

Training of Trainers regarding the application of the Convention on Elimination of all Forms of Discrimination against Women was held in Warsaw, Poland, on 17-23 November. The event was organized by KARAT Coalition and International Women's Rights Action Watch Asia-Pacific and was addressed to female trainers from Azerbaijan,

Kyrgyzstan, Tajikistan and Uzbekistan. It aimed at strengthening the ability of individuals and organisations to understand and apply principles of the CEDAW Convention in their national, sub-regional and regional context. The seven-day program of the meeting allowed the participants to sharpen their understanding of CEDAW as well as of the structural and institutional aspects of discrimination and inequality. Thanks to this event, the pool of resource people, based in the CEE/CIS countries and prepared to conduct workshops on the CEDAW Convention at local, national and regional levels, was significantly enhanced.

CEDAW Committee: 100 Ratifications of the Optional Protocol to CEDAW

The Optional Protocol to CEDAW has now achieved 100 ratifications, with Cambodia as the most recent State Party. By ratifying the Optional Protocol, 100 States have given to women in their countries the necessary tools to hold their governments accountable for alleged violations of their rights, and to have access to remedies if the Committee concludes that their rights have indeed been violated.

It is a big success of the women's movements. However, we must remember that women continue to face obstacles to access justice, such as the lack of access to legal aid, the women's legal literacy and the lack of awareness of their rights and capacity to effectively claim them.

Poland : Parliament passes Gender Quota Bill

The Polish Parliament has approved a bill which aims at promoting greater gender equality in the country's political life. According to the new legislation, at least 35 percent of all candidates on the lists of all parties running for seats in the 460-seat lower house must be women. The rule will not apply to elections to the 100-seat upper house, the Senate.

The idea was launched by the Polish Women's Congress which has prepared the project of the parity (50%) bill and has collected more than 100,000signatures of citizens supporting it. Unfortunately, the original project has been significantly changed by the members of the Parliament.



Now women account for some 20 percent of deputies in the lower house and for only 8 percent of senators. The next parliamentary elections are scheduled for autumn in 2011.

UN: Fact Sheet "Women, Gender Equality and Climate Change"

Climate change is a sustainable development challenge, with broad impacts not only on the environment but also on economic and social development. The effects of climate change will vary among regions, and between different generations, income groups and occupations as well as between women and men. The threats of climate change are not gender-neutral. It is therefore extremely important to apply a gender analysis to all actions on climate change, so that women's and men's specific needs and priorities are identified and addressed.
