## **OP CEDAW: regional coalition expands**



The group of partners working together within KARAT OP CEDAW project in 2009 has increased by organizations in 4 additional CIS countries: Armenia, Azerbaijan, Tajikistan, Uzbekistan. The new partners that were selected as a result of the call announced by KARAT Coalition are: **Women's Rights Center** (Armenia), **Azerbaijan Gender Association "Symmetry"**, **Public** 

**Foundation "Panorama"** (Tajikistan) and **"Generation of the Future"** (Uzbekistan). The project partners will be responsible for implementing the project activities at the national level. The type and scope of these activities as well as the rules for cooperation will be defined during the strategic meeting planned for the end of March. Since not all states mentioned above are parties to the Optional Protocol to CEDAW, one of the project aims is to support the women's NGOs in these countries to convince their authorities to ratify this document.

\*2009 is the second year of the project implementation. Therefore the newly established partnership will build on the experience gained last year by KARAT and women's organizations from Belarus, Georgia, Moldova and Ukraine. Like in 2009, also this year, part of the project activities will be conducted in cooperation with IWRAW Asia Pacific the organization focused on CEDAW for over 15 years. Due to the cooperation between KARAT Coalition and Women's Support Center in Kyrgyzstan greater number of women's organizations in more CIS countries will be involved in the OP CEDAW related activities this year.

#### Women is Supermarkets: round table



State institutions (parliamentarians, representatives of ministries, National Labour Inspectorate, Ombudsman Office), employers and employers' organizations, trade unions, NGOs, lawyers and researchers participated in the roundtable on improvement of the working conditions in supermarkets held in Warsaw, Poland, on 26 February 2009. Recommendations and conclusions from the Round Table will

be send to Chairman of the Three-Sided Commission (government-employers-trade unions) – Prime Minister Waldemar Pawlak.

This was the first time when representatives of super/hypermarket chains and employers' organizations were invited to join KARAT's activitie. We awanted to hear the employers' opinions about recommendations focusing on more effective protection of the employees' rights developed by KARAT's experts (SAAB) and find out what can be realistically done to improve the employees' situation. Unfortunately none of the invited supermarket representatives attended the meeting. This lack of will for dialogue is not understandable especially in the time of economic crisis when multi-stakeholder debate is a key to shape positive approach and the solution satisfactory for all the parties.

\*Up to 90% of the super/hypermarkets staff are women. The research conducted by KARAT in 2008 showed that not the law but its implementation in supermarkets is improper and in result - labour rights protection system often fails. The most obvious infringements include increasing the length of shifts, not observing appropriate breaks between them, the number of days worked without a day off, mobbing. #### MakelTfair: capacity building in Hungary



The workshop on the working conditions in the electronic industry organized in Budapest, Hungary, in February 2009 aimed to inform interested NGOs and civil society actors (such as trade unions) about the MakelTfair campaign and possibilities of cooperation; impact of growing demand for electronic goods on environmental issues; social & economic development in Southern countries and so

called countries in transition. The special attention was given to educational materials and how they can be used further by the interested organisations, groups & individuals in Hungary.

\*MakeltFair is a European campaign, raising awareness about developmental issues in the production of consumer electronics, such as mobile phones, MP3 players and laptops. We want to encourage consumer, especially youth, to get active to improve the situation in the electronic industry. We are trying to make big brand electronics companies accountable – asking them to take responsibility for the labour abuses and environmental damage at the bottom of their supply chain. KARAT takes part in the campaign as a partner from Central Eastern Europe region because of its interest in improvement of women's working conditions. Women constitute the majority of employees in the big brands electronics supply chains.

#### Campaigning for corporate accountability

The European Coalition for Corporate Justice (ECCJ) – with KARAT as one of the funders - plans a public campaign to push for establishment of legal proposals at the EU level to improve corporate accountability (within a three year project co-financed by European Commission). The Extraordinary General Assembly of ECCJ (Brussels, 25-26 February, 2009) aimed at developing a strategy of a successful campaign for the period 2009-2011which foresees legal proposals of better legal obligations (e.g. companies having a duty to prevent human rights abuses), better access to justice by victims, better transparency of companies, as well as a research on violations of social, environmental and human rights standards by companies in the Global South and on legal remedies to address these violations. KARAT, focusing on decent work for women in Central Eastern Europe, and member of ECCJ, participated in EGA. Its representative was surprised by the fact that a case study on violation of human rights in Europe (e.g. documented cases on women in the supermarkets in Poland) would not be taken by the ECCJ in its campaign. As a result a group of ECCJ members explored further the issue of focusing on Europe, namely on new member states (NMS), and identified a need of ECCJ project focusing on violations of human rights by companies in NMS and strengthening cooperation with organizations from these countries.

## Financing for Development (FfD): joining the debate

Kasia from KARAT Secretariat joined the WIDE Ad Hoc Working Group: Financing for Gender Equality that met in Brussels on February 20<sup>th</sup> 2009. The group's main mandate is to monitor and advocate for gender equality in the center of development agenda and new aid architecture process. The February

meeting focused on elaborating an action plan for 2009 -2012 with regard to the current global financial crisis.

\*Gender & Development is one of the 4 thematic priorities in the KARAT Program for 2009-2012. In the last Board Meeting it was agreed that the participation of women from CEE & CIS in the EU & global development discourse / process should be increased. This aims to make the Region more visible and make a link between East, North and Global South.

KARAT is WIDE (Women in Development Europe) regional platform. WIDE constitutes a European feminist network of women's organizations, development NGOs, gender specialists and women's rights activists that monitors and influences international economic and development policy and practice from a feminist perspective.

# VESTA Association (BiH): preventing violence agianst adolescents

Withe the support from UNIFEM VESTA Association is starting a new project Preventing violence against girls and promotion of gender equality values among adolescents. The project aims to fill the reserach gap

examining the mainfestations of adolescent dating violence and develop the mechanisms for the preventive actions and the suppresion of violence in such relationships. The project adresses the increasing number of reports on girls being brutally murdered by their boyfriends in Bosnia and Harzegovina. The project has a strong media component.

## Gender Studies o.p.s (Czech Republic): for the Barcelona targets

Czech women's rights organizations do not agree with the government position on questioning the targets of the Barcelona process. According to Gender Studies o.p.s Barcelona Targets will secure wider options for Czech parents since the current supply of childcare services or facilities is inadequate and

insufficient, effectively preventing women (parents) from returning back to the labour market any sooner than after three years after the birth of their child. Barcelona targets aims to provide childcare services for at least 90% of children between the ages of three and school age, and for at least 33% of children younger than three by 2010.

# Women's Support Center (Kyrgyzstan): campaign on safe maternity

Official meeting with the bussines representatives, international and local NGOs staff and media held on 10<sup>th</sup> of February 2009 launched the capaign by the Kyrgyz women's rigts organizations on reducing maternity death rate. Maternity death rate in Kyrgyzstan is particularly high: 100 women die in chilbirth per yer, while in western countries the number is 15. The campaign aims to inform the public about the safe motherhood. With this regard the presents for 8 of March that are available in the Bishek supermarkets will contain the campaign messages. Profit from the sale on 5 – 7 March will be donated to National Care Center for Mothers and Children where the women from the entire country with the most difficult pregnancies are treated.

## Felicitas (Serbia): new projects on the labor market



Citizens Against Mobbing and Concealing Center for Small and Medium Enterprises are the titles of two projects that Citizens' Association Felicitas will be strarting in April 2009. The first one is the continuation of the advocacy work on Law on Mobbing in Serbia with the overall goal to contribute to changes and amendemnts to the Labour Law concerning protection from all forms of harassement in the broader

sense. The second will provide serious education for unemployed – particulrly women between 40 –60 years of age that lost their jobs due to the transition process - for starting small / medium seize enterprise.

On 6<sup>th</sup> of February United Nations Committee warned that current global crisis is likely to have a serious impact on the full realization of gender equality. It stressed that particular attention must be paid to providing women an access to programmes aimed at alleviating poverty and hunger, as well as to a guarantee that national and international efforts effectively reach those most in need and that funding of programmes for women's empowerment is not eroded. It called all the States parties of CEDAW to o comply with all their obligations under the treaty in spite of the financial crisis.
