What's new in KARAT?

KARAT at CSW in New York

KARAT is going to hold a side event on February 28th 2012 during the 56th session of Commission on the Status of Women (CSW) in New York. The event will be based on the outcomes of project on CEDAW implemented in Central Asia and Caucasus. It will explore the impact of traditional value systems on the rural women's ability to exercise their rights. It will also focus on the interrelations between women's access to justice and their economic position in the family and society.

The panelists from Azerbaijan, Kyrgyzstan, Tajikistan and Uzbekistan will also discuss the cultural, religious and socio-economic barriers that stop women from using legal and other means to protect their rights. The panel will provide the space for women's rights NGOs to share their experiences in challenging the harmful practices related to traditional and/or religious values that disempower women for example by decreasing their economical independence. The panelists will also present the proposals for actions aimed at improving the situation of women in rural areas that had been formulated by women's rights NGOs in their countries.

Women's perspective in Polish development cooperation policy

There is a chance that gender equality issue will be more visible in the Polish development cooperation policy. Two new bodies were established within the Polish development aid structures: the Foundation of International Solidarity and the Programming Council of Development Cooperation. These two bodies, and particularly the Programming Council of Development Cooperation which has four places reserved for representatives of CSOs, are the potential partners in discussion for inclusion of women's rights issue into the Polish development cooperation policy. They are to be more democratic and more open to CSOs' recommendations. The establishment of new bodies caused some personal reshuffles within the development aid structures including appointment of new Undersecretary General of State.

These changes are welcomed by KARAT Coalition which hopes that the newly appointed Undersecretary General of State will be a key person for forthcoming gender oriented advocacy activities conducted by KARAT and by Zagranica Group.

Albania: Social auditors check the authorities' performance in gender equality area

In four Albanian municipalities the local authorities have been assessed by the social auditors in terms of their gender sensitive policies. The auditors prepared the Monitory Report which indicates the weak points of the local governments' policies concerning such issues as domestic violence, women's economical empowerment and women's involvement in decision-making process at the local level. They also developed recommendations for the authorities on how to improve implementation of gender equality policy in the local communities.

The social audit on a gender oriented policy of the local governments is a new practice in Albania. The auditors, members of the local communities, are trained about the community's rights to be involved in a decision-making process, women's rights, authorities' responsibility for gender sensitive policy and the techniques of social auditing by the trainers from Gender Alliance for Development Centre. The Centre plans to conduct trainings of the social auditors also in the other municipalities and communes of Albania in order to make local authorities be more sensitive to women's needs and improve cooperation between them and members of community.

Macedonia: Young people against ethnic violence

At the end of January in three different multiethnic municipalities of Macedonia the representatives of local governments, CSOs, and young people from local communities took part in the seminars concerning implementation of the United Nations Security Resolution 1325 (UNSCR 1325) at the national level and its role in enhancement of a dialogue between local stakeholders and young people.

The participants gained a specific and relevant knowledge about the UNSCR 1325, and learnt how to cooperate with each other for better gender sensitive and inter-ethnic dialogue to build peace and safety in a multicultural society. They listened to the lectures and took part in the activities based on solving problems through cooperation.

The seminars were the part of the project "Young Women's Participation in Inter-Ethnic Dialogue, Peace and Security" implemented by the Youth Centre for Equal Opportunities from Macedonia. The project focuses on promoting and enhancing a dialogue among young women and men from different ethnic groups to empower them to participate in the peace—keeping and decision-making process in the country where the acts of violence between ethnic communities still take place.

Romania: Discrimination in the toy industry



In December 2011 the Romanian viewers had a chance to watch a TV spot concerning the poor working conditions in Chinese toy companies. The spot was a part of the campaign "Stop Toying Around" which is an element of European project aiming at raising awareness among European consumers, media and decision—makers about bad situation of Chinese workers who produce the toys for European markets. In December Romanians could also express their concern about discrimination of Chinese workers in toy industry by signing a petition in support of improving their working conditions. The signatures were collected during the awareness raising campaign

conducted in Bucharest by the campaign activists and project's coordinators from the National Association of Human Resources Specialist – "AUR". The campaign on the Bucharest's streets initiated the second European Speakers Tour 2011.

Poland: Abortion returns to Parliament

An anti-clerical political party "Palikot's Movement" wants to spark renewed debate in the Polish Parliament about the women's access to legal abortion. In January the party submitted the draft legislation that allows a woman to have an abortion up to 12 weeks of pregnancy without having to give a reason for her decision. Although the Polish abortion law is one of the strictest in Europe the initiative to liberalise it is not supported by many members of Parliament. Most of the Polish MPs consider the current abortion law as a good compromise between the state and the church and do not take into consideration the fact that a fundamental woman's right to decide about her own reproduction is violated.

In Poland there are not more than 500 legal abortions annually, but the women's groups estimate that the number of illegal abortions is more than 100,000 each year. Illegal abortion is punishable by up to 2 years of imprisonment for those who perform it and aid in it, although woman who has a termination is not liable.

Danish Presidency focuses on gender equality

The Danish Presidency of the Council of the EU which has just started will focus on three areas of gender equality: women and environment, women on boards and gender-based education choices.

In June 2012 the Council will publish a report on how the EU has implemented the recommendations from the Platform for Action along with a set of indicators on the unequal balance in decision-making in the area of climate change as well as the lack of women in Science, Technology, Engineering and Mathematics (STEM) in the educational system. Further, in March 2012 the European Commission will publish its State of the Union report in relation to women on boards in public and private companies in Europe. At the end of the Danish Presidency it is planned to present the best practices and new knowledge on how to promote more girls and women into STEM. The gender-divided educational system and the lower number of boys in the system present serious problems for society as well as for the promotion of gender equality.

PACE calls to prevent violence against women

In a resolution adopted on January 26th 2012, Parliamentary Assembly Council of Europe (PACE) called on the member states which have not yet done so to sign the <u>Council of Europe Convention on Preventing and Combating Violence Against Women and Domestic Violence</u>. The convention provides a comprehensive framework for preventing violence against women, protecting its victims and prosecuting the perpetrators.

The Assembly also asked member states to take a series of measures to promote the convention and facilitate its signature and ratification. PACE stressed that the national parliaments should urge their governments to sign and ratify the convention and conduct activities to raise awareness amongst the general public, practitioners and NGOs.

UN: Women and new climate agreement

A new climate agreement "Durban Platform" developed during the UN climate talks in South Africa, has increased the gender equality commitments of the states. The Platform highlights 11 commitments to gender equality, including a new agreement to create an international Green Climate Fund to help protect underprivileged nations from weather disasters and transition to cleaner energy systems. The creation of the Green Climate Fund means that for the first time a climate finance mechanism will be established with gender aspects integrated right from the beginning.

The results of the UN climate talks are important especially for women in developing countries since they comprise 43 percent of the agricultural workforce there. The women are more prone to suffer the consequences of the natural disasters and other effects of climate change, because due to the discriminatory practices they have fewer social and economic resources than men.

IACHR – Report: The Work, Education and Resources of Women: The Road to Equality in Guaranteeing Economic, Social and Cultural Rights

The Inter-American Commission on Human Rights (IACHR) has published the report "The Work, Education and Resources of Women: The Road to Equality in Guaranteeing Economic, Social and Cultural Rights". The IACHR has observed that, where economic, social and cultural rights are concerned, the discrimination against women continues to be evident in the labour market, in women's limited access to social security, in the high rates of illiteracy among women and girls as compared to men, in the extreme poverty and social exclusion which affects women, and in the little opportunities of political participation for indigenous and Afro-descendent women, among other relevant issues.
